NOTICE TO BIDDERS

Sealed bids will be received by the Hamilton County Clerk, Hamilton County Courthouse, 1111 13th Street, Suite 1, Aurora, NE 68818, until Thursday, January 7, 2021 at 10:00am CDT, for construction of Asphaltic Concrete Overlay Projects – Giltner Road H, Road K, and Sunset Terrace and other work incidental thereto located in Hamilton County, Nebraska. The sealed bids are to be plainly marked “Attention: Hamilton County Clerk, Asphaltic Concrete Overlay Projects - Giltner Road H, Road K, and Sunset Terrace, Hamilton County, Nebraska.”

The sealed bids are to be sent or submitted to the Clerk of Hamilton County, Hamilton County Courthouse, 1111 13th Street, Suite 1, Aurora, NE 68818. Bids will be opened at 11:00am on Thursday, January 7, 2021, at 10:00am CDT at the Hamilton County Highway Department at 1509 A Street in Aurora NE 68818.

The work shall include all labor, materials, transportation, and equipment required for the construction of:

Asphaltic Concrete Overlay Projects - Giltner Road H, Road K, and Sunset Terrace

Proposals must be submitted on the forms furnished with the Bid Documents. **Please only submit Division 5.**

Each bidder will be required to submit with his proposal a Bid Bond or Certified Check made payable, without condition, to the County Treasurer of Hamilton County, Nebraska, in an amount equal to five (5) percent of his proposal.

The bidder to whom the contract is awarded shall furnish within ten (10) days after the award a surety bond or bonds in a sum equal to the full amount of the contract. The form of the bonds and surety shall be acceptable to the Hamilton County Board of Commissioners.

The bidder will include an estimated time of beginning and completion for the project with the proposal. The required completion date of the project is September 15, 2021. The Contractor will be allowed 30 calendar days for completion. The Contractor may begin work on the project at any time after entering into a contract with Hamilton County.

The Board of County Commissioners reserves the right to reject any and all bids or to waive any irregularities in bids.

Awarding of the Contract will be in accordance with the eleven points enumerated under “Competitive Bidding; consideration”, COUNTY PURCHASING ACT, N.R.S. Sections 23-3110 through 23-3114 and the County Board will, at their discretion, award based on the lowest responsible bid. Hamilton County is an Equal Opportunity Employer.
